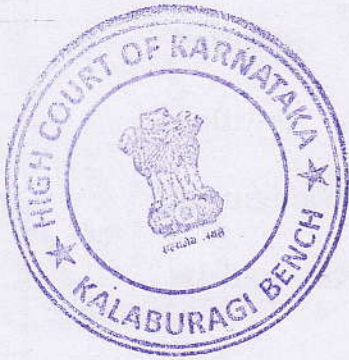
4) Petitioner shall web host in their web site i.e., www.tipusultanunanimedicalcollege.org about
