Learned counsel appearing for the parties submitted ad-idem that the Cognate Bench of this Court in identical circumstances, in Writ Petition Nos.47294-295/2018 and Writ Petition Nos.203458-203459/2019 has passed an interim order permitting the petitioner's institution to admit * (BUMS) * the students Undergraduate – UG (BAMS) Course in accordance with the procedure prescribed subject to certain conditions and petitioner herein is entitled to similar relief on the rule of parity.

The said submission is placed on record.

Having regard to the submission of the learned counsel for the parties and perusing the material on record, this Court is of the considered opinion that the petitioner herein is entitled to the similar relief as that of the order

The petitioner is permitted to admit 60 students to the *(BUMS) UG (BAMS) Course in accordance with the procedure for the academic year 2019-2020 during the pendency of the writ petitions subject to the following conditions;

- Petitioner filing an affidavit of undertaking that writ petitioner would not claim any equities in the event of writ petitions are being dismissed;
- Petitioner shall file an affidavit of the Principal of petitioner's institution certifying that pendency of this writ petition will be individually intimated to all the students who have admitted and the acknowledgment obtained from each students shall be filed along with staid affidavit;
- 3. The students who are likely to be admitted are not parties to these proceedings hence, it is made clear that such students would also not be entitled to claim any equities or contend at a later stage that they would be entitled to be continued in the course or their admission is to be regularized;
