4. Accepting the submission made by learned counsel appearing for both the parties, writ petition is **disposed of** in terms of the aforesaid writ petition.

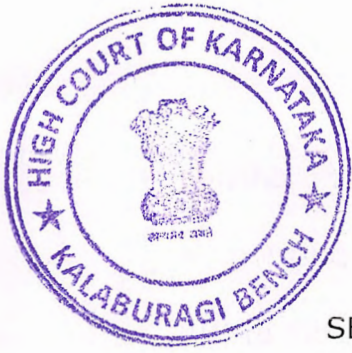
